PUBLIC NOTICE NO. 04/2022

It is brought to the notice of all concerned, including general public and stakeholders, that the area measuring 1,67,383 Sq. Mtrs. (including Berth No. 14) within the jurisdiction of the New Mangalore Port Trust (NMPT), Mangaluru, will be operated by M/s JSW Mangalore Container Terminal Pvt. Ltd., (JSWMCTPL in short) in terms of the concession agreement dated 27.01.2020 entered into with M/s NMPT.

The above area which includes 12250 Sq. Mtrs Berth area of Berth No.14, 15133 Sq. Mtrs. for truck queuing and connectivity and 65000 Sq. Mtrs. of container storage with an additional area of 75000 Sq. Mtrs. for proposed Stackyard behind the Container Yard has been declared as Customs Area in terms of the Notification No.02/2018 dated 25.06.2018 issued under the Customs Act, 1962.

Now, therefore, M/s JSW Mangalore Container Terminal Pvt. Ltd., Mangaluru, have been appointed as the Custodian of the imported goods received in the above mentioned entire area (notified as Customs Area vide Notification No. 02/2018 dated 25.06.2018) until these goods are delivered to the Container Freight Stations or are removed/ transhipped in accordance with the provisions of Chapter VII and Chapter VIII of the Customs Act, 1962. Similarly, M/s JSW Mangalore Container Terminal Pvt. Ltd., will also be Custodian of the Export Cargo brought into said notified area, till their exportation through New Mangalore Port.

Further, M/s JSW Mangalore Container Terminal Pvt. Ltd. is appointed as a “Customs Cargo Services Provider” for the above mentioned entire area (Notified as Customs Area vide Notification No. 02/2018 dated 25.06.2018) located within the jurisdiction of major port,

New Mangalore Port Trust, Mangalore, in exercise of Regulation 10 of the Handling of Cargo in Customs Areas Regulation, 2009, as amended, subject to following conditions:

1. The Custodian, M/s JSW Mangalore Container Terminal Ltd., who have been approved as Customs Cargo Services Provider for the entire notified area, shall abide by all the provisions of the Customs Act, 1962 and regulation made under “Handling of Cargo in Customs Area Regulations, 2009” along with the other Regulations, Notifications, Orders issued thereunder.
2. Duration of the appointment of M/s JSW Mangalore Container Terminal Ltd. as “Custodian” and also as the ‘Customs Cargo Services Provider” shall remain valid for two years from the date of issue of this Public Notice.
3. The Commissioner of Customs, Mangaluru, shall have the right to review the approval as “Customs Cargo Services Provider” before the completion of two years for failure to comply with any of the provisions of the Customs Act, 1962 and/or the Regulations of the “Handling of Cargo in Customs Areas Regulations”, 2009, as per the directions of the Government of India.

The importers/ CBs/ Industry/ all stakeholders are requested to make use of this facility.
