NOTICE TO ALL STAKEHOLDERS

Attention of all stake holders are invited that BPCL Liquid Cargo Terminal (LB01 & LB02) will be shut down in two phases as detailed below for carrying out strengthening of pipeline trestle and pipeline's extension from LB01 / LB02 to LB03 / LB04.

First Phase	-	From 09-Sep-25 to 11-Sep-25
Second Phase	-	From 06-Oct-25 to 08-Oct-25


During this shutdown period, no vessel operations will be carried out at LB-01 and LB-02, as the strengthening works have been meticulously planned and vendors have been mobilized accordingly by M/s BPCL and M/s JJLTPL. However, JJLTPL berths LB-03 and LB-04 will remain operational during this time.

All stakeholders are requested to take note of this shutdown schedule and plan vessel movements accordingly. No requests for vessel placement at LB-01 and LB-02 during the shutdown period will be entertained.

Tank farm operators are encouraged to utilize this window to undertake any pending maintenance or works related to pipeline systems, ensuring minimal disruption.
