In line with the Ministry of Ports, Shipping and Waterways' (MoPSW) vision of achieving standardization, enhancing transparency, and ensuring ease of doing business, a comprehensive Port Process Mapping Study titled "One Nation, One Port Process" has been undertaken across all major ports.

As part of this initiative, a standardized list of documents applicable to portrelated processes has been developed through extensive consultation with all ports. These standardized processes and document requirements are to be implemented uniformly from **01.01.2025** to streamline operations and promote seamless trade facilitation.

At New Mangalore Port Authority (NMPA), the above standards have been fully adopted effective **01.01.2025**. To ensure compliance and effective implementation, an internal committee comprising the following officers has been constituted. The committee will conduct implementation audits and submit quarterly reports to the Ministry:
