Sub: Registration of unorganized Dock Workers on e-SHRAM portal.

Ref: Circular No. TM/S-1/76 dated 29.10.2021

By referred Circular dated 29.10.2021, it was requested for registration of all such workers who are coming under the category of unorganized workers through the facility available on e-SHRAM portal or with the help of Common Service Centres (CSCs) in Mumbai, details of which are available on e-SHRAM portal. It was also requested that details of such registration i.e Name of the worker, their Universal Account No. (UAN) and date of registration may kindly be informed to Dock Entry Permit Section on daily basis on e-mail address:- dep.mbpt@mumbaiport.gov.in.

However, information on such registrations made is still awaited.

2. Although facility for registration is available on e-SHRAM Portal and also Common Service Centres (CSCs) for registration are available in Mumbai, with a view to provide facilitation, a counter for registration on e-SHRAM is set up by Mumbai Port Trust at Shramik Bhavan, Near Yellow Gate Indira Dock, Carnac Bunder, Mumbai 400009, with effect from 07.12.2021, which is operating from 9 am to 5 pm.

- 3. As per FAQ (Frequently Asked Questions) available on the e-SHRAM website -
- "Any worker who is a home based worker, self employed worker or a wage worker, working in the unorganized sector and not a member of ESIC or EPFO, is called an unorganized worker"
- 4. It has been decided that all such workers shall be registered on e-SHRAM by 01.01.2022. Therefore, all the Port Users are requested to ensure that their workers are registered on e-SHRAM Portal by 01.01.2022. As requested by circular dated 29.10.2021, details of registration, if made on e-SHRAM portal or with the help of Common Service Centres (CSCs), may kindly be informed to Dock Entry Permit Section on daily basis on e-mail address:- dep.mbpt@mumbaiport.gov.in.
- 5. This is an important initiative of Government of India. If registration of such workers is not done by due date, Dock Entry Permits (DEPs) will not be issued from 01.01.2022. You are requested to give wide publicity in this regard amongst your members.
