<u>M.S. Notice – 11 of 2020</u>

Sub:Routeing system in South West Indian Waters- reg.

1. The Arabian Sea around the south-west coast of India is a busy sea route with substantial number of ships passing through the area and also has large number of fishing vessels operating in this area.

2. The presence of large number of merchant vessels and fishing vessels operating in the area has resulted in several incidents of collision in Indian waters. The accidents between merchant vessels and fishing vessels have not only resulted in loss of property and environmental pollution but in several instances, it has also resulted in loss of precious lives.

3. Considering these incidents of collision in Indian waters, it has become necessary to have a mechanism for marine traffic to safely operate in the areathat will not only ensure improvement in safety of navigation, avoidance of collision, ease in flow of traffic and the avoidance of areas of heavy fishing traffic, but also contribute towards enhancing the safety of life at sea, safety and efficiency of navigation, and/or protection of marine environment.

4. The coordinates of the routeing system in South-West of Indian waters is provided in Appendix –I of this notice. The said coordinates have been reproduced on INT Chart No – 22/32/221/222/259/260/273 (Annexure –II not to be used for navigation) for reference.

5. It is recommended that shipping traffic in the region may use therouteing system, so that safety of life at sea, safety and efficiency of navigation, and/or protection of marine environmentcan be improved in the region.

6. This Merchant Shipping Notice comes into force with effect from 01^{st} August 2020 (01/08/2020).


